

Annual Meeting of Member-Owners Minutes

Bay City Civic Center, Matagorda County, Texas | Saturday, September 21, 2024

The 2024 Annual Meeting (2023 Annual Report) of the members of Jackson Electric Cooperative Inc. was held on Saturday, September 21, 2024, at Bay City Civic Center, Matagorda County, Texas, with registration beginning at 9 a.m.

Herff Cornelius, President, called the meeting to order at 10:05 a.m. and thanked those attending for their participation in the Annual Meeting. President Cornelius asked the members to rise for the national anthem performed by Dawson Hudgins followed by the Invocation given by Board Member Anthony Smith. Board Secretary-Treasurer Michael Jacobs presented the Notice of Meeting and proof of mailing thereof to all members of the Cooperative on August 30, 2024. The notice and proof of mailing were ordered to be attached to the minutes.

Director Jacobs reported 120 members present in person as of 10 a.m., which constitutes a quorum of the members of the cooperative.

President Cornelius announced that the meeting would be dedicated to the U.S. Armed Forces.

Director Jacobs was again called upon for the reading of the minutes of the October 21, 2023, Annual Meeting. Upon motion duly made and seconded to dispense with the reading of the minutes and to approve said minutes, the following resolution was adopted:

RESOLVED, that the Jackson Electric Cooperative Inc. membership hereby approves the October 21, 2023, Annual Meeting Minutes as written.

Motion carried.

General Manager Jim Coleman introduced special guests, the Cooperative's Board of Directors and retired employees.

Attorney John Merck recognized the Nominating Committee members and expressed appreciation of the Cooperative for their service. They were Barbara Juranek and Jonel Knuppel. Mr. Merck then reviewed the nominating procedure.

Mr. Merck stated that all Districts were unopposed and shall be elected by acclamation at the next board meeting.

Director Jacobs gave an updated Treasurer's Report for 2023, with no changes since the Cooperative's Annual Audit. Upon motion duly made and seconded, the following resolution was adopted:

RESOLVED, that the Jackson Electric Cooperative Inc. membership hereby approves the Treasurer's Report for 2023 as presented.

Motion carried.

President Cornelius gave the President's Report, which reflected on the Hurricane Beryl, JEC Propane and Generac Generators along with an update of JEC Broadband. Mr. Cornelius also discussed the rate increase and the Electric Reliability Council of Texas.

Mr. Coleman gave the General Manager's Report, expanding on some of Mr. Cornelius' talking points and added other projects that the Cooperative is involved in, such as the National Rural Electric Cooperative Association International program. Mr. Coleman also discussed the fiber expansion into Jackson County and thanked the board of directors for their role in delivering reliable electricity and the staff for their continued commitment to excellence.

Damien Coleman discussed improvements to the distribution system, vegetation management and upgrading the meter system.

President Cornelius called upon Kealeigh Alex to introduce the recipients of a \$1,000 scholarship.



Rural Friends and AEC are grassroots political action committees. Rural Friends has more than 4,600 members in Texas, and AEC has more than 35,000 members across the country.

Rural Friends makes campaign contributions to candidates for the Texas Legislature and statewide nonfederal offices. AEC makes campaign contributions to candidates for Congress. Both PACs contribute to those who support electric cooperatives' goals and who share our cooperative values.

Rural Friends and America's Electric Cooperatives raise personal, voluntary contributions from their eligible memberships. Federal law prohibits soliciting contributions for AEC from individuals other than national and state cooperative associations and their member-systems' eligible employees, boards of directors, consumer-owners and the family of such individuals. Contributions from ineligible individuals will be returned.
